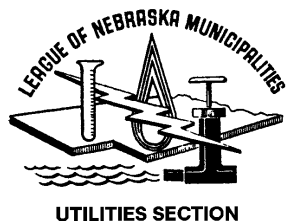

We also would encourage attendance of all municipal officials who would like more information concerning the solid waste and recycling industry.
